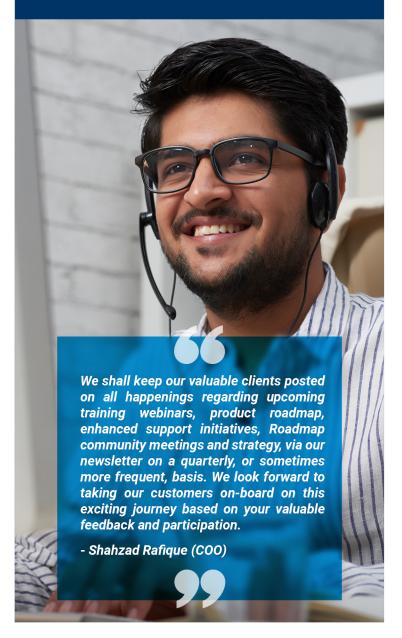
We would like to thank all those who took the time to respond to the detailed survey. We also enjoyed speaking to many of our customers to discuss the feedback and suggested areas of focus.
